About the Center



OUR MISSION

Our vision is a community where workers are respected and treated with dignity and fairness. To bring that vision into reality, we provide legal representation to low-wage workers, advocate for initiatives to advance workers' rights, and promote worker education, activism, and leadership in the greater Sacramento area.

WHO WE HELP

The Center is open to all workers regardless of immigration status. Income guidelines determine eligibility to receive our free legal services. We assist those workers most vulnerable to workplace abuse, including undocumented immigrants, pregnant women, caregivers, people of color, victims of domestic violence, and members of the LGBTQ community.

OUR WORKERS' RIGHTS CLINICS

Together with Legal Aid at Work in San Francisco, the Center for Workers' Rights organizes Workers' Rights Clinics in Woodland and a summer program for McGeorge Law School students in Sacramento. Law students meet with workers one-on-one, under the supervision of knowledgeable volunteer attorneys. The clinics provide accurate, applicable, and free information to working people on their rights when issues arise in the workplace.



WAGE THEFT RECOVERY

Since its founding in 2014, the Center has won more than half a million dollars in wages and penalties through claims filed with the California Labor Commissioner. This fall we piloted a new program, a Wage Claim Clinic, where workers receive individualized legal advice, assistance in calculating wages owed, and an explanation of how to pursue their wage claims through the California Labor Commissioner's office. In its first two sessions, we filed claims requesting payment of approximately \$584,000 in unpaid wages and penalties.

COMMUNITY EDUCATION

The Center for Workers' Rights educates local workers, small businesses, unions, and community members about workplace laws and the practical reality of enforcing those laws. Topics covered include:

- Wage theft
- Sexual harassment
- Taking time off from work
- Reasonable accommodations
- Workplace immigrant rights

We also engage in public education campaigns and policy advocacy to bring attention to the recurring issues faced by workers seeking legal services from the Center.
